## **BACKGROUND**

When the Placentia Library District first opened in 1919, it was designed to serve a population of less than 2,000 by loaning books to the residents of Placentia. Fast forward nearly 100 years later, the Library is the hub of the community, serving a population of 52,228 residents. Almost 325,975 people visited the Library and 280,710 items were loaned in 2016-2017.

The roles filled by the Library have changed dramatically, mainly due to rapid innovation due to technological developments. The Library is a place for education and self-help opportunities, it transforms lives through literacy, and it changes communities by supporting community and civic engagement. It is a place that welcomes everyone equally, offers visitors a place to stay in touch with their families, friends, and business associates while encouraging users to contribute back to their communities.

The focus of the renovation will be improving the building space to accommodate 21st century technology and community needs. The Library is the one place in the community that is free and accessible to all, every day of the week. Existing space will be reconfigured to reflect the community's needs and inputs based on library best practices and emerging service trends. We embrace the Library's new roles of a convener, creator, collaborator and connector of innovative spaces for our community. The new space is designed to create new experiences that help to inspire, imagine, and innovate.

In 2017 and 2018 presentations were made to community partners and the public with charrette exercises in 2017 and conversations held in 2018. On June 28, 2017, the Library Board of Trustees adopted the 2017-2019 Fiscal Year Budget. The Budget included a capital improvement plan for renovation of the public area and implementation of an energy efficiency project.

On November 13, 2018 the Library began a formal competitive bidding process for the renovation project. Three companies participated in the onsite walkthrough with library staff. On December 12, 2018, the Library completed the bidding process. One bid from Cal-City Construction was received, in the amount of \$1,469,100. At the December 18, 2018 Unusual Date Board meeting, the Board approved library staff to pursue a

discussion of the budget with eMar Studio and Cal-City Construction for a total project not to exceed \$2.5 million in total. At the January 23, 2019 Unusual Date Board meeting, a decision was made to reject all bids and re-advertise the Request for Proposals (RFP) as the cost reductions proposed by Yamada Enterprise and Cal-City Construction would eliminate key service model component of the project.

The RFP was re-posted on the District's website, front entrance display case, and on Dodge Data & Analytics (construction and bidding website). Additionally, library staff received recommendations from other libraries and local chamber of commerce and followed through with an invitation to submit bids.

On February 28, 2019, the District received three proposals.

Attachment A is the Bid Tabulation.

Attachment B is the proposal from Alonco Construction, Inc. (\$1,099,898) – Performance bond was not provided

Attachment C is the proposal from Cal-City Construction, Inc. (\$1,198,880)

Attachment D is the proposal from Vincor Construction, Inc. (\$1,194,213.73)

State law requires the Library District to award the contract to the lowest responsible bidder; provided the bidder's bid is responsive to the request for bids. The Board of Trustees may waive minor variations in a bidder's bid, as long as such variations do not give the low bidder a competitive bidding advantage. In this case, the lowest bidder submitted a performance bond for only 36% of the bid price. The request for bids requires a performance bond at 100% of the bid price. Given that a 36% performance bond would be less expensive that one for 100%, the lowest bidder gained a competitive bidding advantage over the other bidders. In addition, it is routine for public agencies to require a performance bond at 100% of the contract price to protect the public agency in the event the contractor awarded the bid does not perform. A 36% performance bond would not provide the Library District with that level of protection. Finally, the inability of a contractor to get a 100% bid bond can be, in some cases, evidence of the financial capability of the contractor. For the above reasons, staff's recommendation is that the Board of Trustees find that the lowest bid submitted by Alonco Construction, Inc. be found non-responsive and that the contract for the Library remodel be awarded to the second lowest bidder, Vincor Construction, Inc.

Alonco Construction is a general contractor that is perfectly capable of performing the work required to complete the project at the Placentia Library at prevailing wage. Unfortunately, Alonco Construction is not able to obtain a bond equal to the amount of the contract. The max bonding achievable by Alonco Construction is \$400,000.00. Therefore, there is no bid bond or performance bond accompanying this attached bid. Alonco Construction is submitting without bonding and this explanation per my conversation with Jeanette Contreras.

This job could easily be done by setting up a proper payment schedule assuring payments are made as the work is completed and accepted by the library or city inspectors. The last two large projects Alonco Construction performed were done in this manner and without performance bonding. Also the cost of the bond would cost the library an additional \$30,000.00 for a bond covering the full amount of the project.

The only way Alonco Construction would be able to do this work with bonding would be to possibly split it up in three contracts in order for Alonco Construction to bond up.

#### ADDITIONAL TERMS AND CONDITIONS

- 1. Terms and Conditions. These are the printed terms of the contract and are included as part of your agreement with Contractor. The terms are legally binding, please read carefully.
- 2. <u>LIABILITY LIMITATION</u>. Contractor makes the following express, limited warranty: Contractor will perform its work in a good and workmanlike manner; it will use the degree of care and skill ordinarily exercised under similar circumstances by members of its profession. This warranty is in lieu of all other warranties or representations either express or implied. Should Contractor be found negligent in the performance of its work or to have made and breached any express or implied warranty, representation or contract, Owner agrees that the maximum aggregate amount of liability of Contractor shall be limited to \$25,000.00 or the total amount paid to Contract, whichever is greater.
- 3. Code Violations. Contractor is not responsible for existing violations of local building codes and/or ordinances.
- 4. Personal Guarantee: Whether the undersigned signs on behalf of an individual, sole proprietor, corporation, partnership, or other entity, the undersigned irrevocable and unconditionally personally guarantees payment for the Subject Work.
- 5. Assignment. Contractor has the right to assign or delegate rights and/or duties under this Contract, including without limitation any right to compensation under this Contract. Owner may delegate or assign duties under the Contract but shall remain personally liable for compensation to Contractor.
- 6. Attorneys' Fees. The prevailing party in any demand, action, judicial proceeding, motion or arbitration shall be entitled to recover from the unsuccessful party all costs, expenses, actual attorneys' fees and expert witness fees relating to and/or arising out of such demand or proceeding and/or arising out of any post-judgment proceeding. Any award or judgment shall contain a specific provision for the recovery of all subsequent costs, expenses, actual attorneys' fees and expert witness fees incurred in connection with any post-judgment collection action. Owner acknowledges that Contractor's damages shall include lost profits, overhead, incidental and consequential damages.
- 7. Hold Harmless Agreement. Contractor is not responsible for damage resulting from flood or fire, including but not limited to water, sewage, or smoke. Contractor shall not be liable for existing conditions, including, but not limited to water damage, smoke damage, fungi, mold, mildew, poor indoor air quality, sick building syndrome, asbestos, biological or chemical hazards, latent defects, prior flooding and structural problems. Contractor in no way will be held liable for natural consequences of flooding, fire, mechanical malfunction or interferences of work by any other entity or party involved. Contractor is not responsible or liable for any persons or animals that remain at the premises or in the structure during work. Owner agrees to indemnify and hold Contractor harmless and agrees, at its own expense, to defend any suit or action brought against Contractor founded on or arising out of such damages, conditions or claims.
- 8. Stop Work. Should Owner fail to issue payment within 5 days of a demand, notice or invoice from Contractor, in addition to all other remedies available, may stop work and/or terminate the contract and enter the premises and remove any portion of or all materials or goods installed or affixed to the Property as part of the Subject Work so long as the removal does not substantially interfere with materials or goods not part of the Subject Work.
- 9. Schedule of Progress Payments. Owner will provide progress payment for the value of each scope of work within 5 days after notice that the respective scope of work is completed. The Progress Payment

will be for the amount as outlined in the respective schedule of progress payments, which describes the phase of work and the amount owed.

- 10. Note About Extra Work And Change Orders. Extra Work and Change Orders become part of the contract once the order is prepared in writing and signed by the parties. The order must describe the scope of the extra work or change, the cost to be added or subtracted from the contract, and the effect the order will have on the schedule of progress payments. Contractor's failure to comply with the requirements of this paragraph does not preclude the recovery of compensation for work performed based upon legal or equitable remedies designed to prevent unjust enrichment. Further, Owner acknowledges and agrees that in performance of the Project changes may be made at any given day and, for efficiency and time sensitivity, may be performed before a change order is written and executed. Owner specifically agrees to execute, within 24 hours, any change order presented by Contractor. If Owner disputes the change order, or any portion thereof, they must immediately, but in no event more than 24 hours after receipt, inform the Contractor in writing of the dispute and Contractor shall have the right to immediately cease work until such change order is resolved or stop work under section 8 above. Any time period wherein Contractor stops work, consistent with the terms of this agreement, will automatically extend the completion deadline for the same amount of days that work is stopped plus an additional 2 days in order for Contractor to recommence scheduling of the work.
- 11. Commercial General Liability Insurance (CGL). Contractor carries commercial general liability insurance as of the date of this contract.
- 12. Workers' Compensation Insurance. Contractor carries workers' compensation insurance for all its employees.
- 13. Mechanics Lien Warning. Anyone who helps improve your property but who is not paid may record what is called a mechanics' lien on your property. A mechanics' lien is a claim, like a mortgage or home equity loan, made against your property and recorded with the county recorder. Even if you pay your contractor in full, unpaid subcontractors, suppliers, and laborers who helped to improve your property may record mechanics' liens and sue you in court to foreclose the lien. If a court finds the lien is valid, you could be forced to pay twice or have a court officer sell your home to pay the lien. Liens can also affect your credit. To preserve their right to record a lien, each subcontractor and material supplier must provide you with a document called a '20-day Preliminary Notice.' This notice is not a lien. The purpose of the notice is to let you know that the person who sends you the notice has the right to record a lien on your property if he or she is not paid. BE CAREFUL. The Preliminary Notice can be sent up to 20 days after the subcontractor starts work or the supplier provides material. This can be a big problem if you pay your contractor before you have received the Preliminary Notices. You will not get Preliminary Notices from your prime contractor or from laborers who work on your project. The law assumes that you already know they are improving your property. PROTECT YOURSELF FROM LIENS. You can protect yourself from liens by getting a list from your contractor of all the subcontractors and material suppliers that work on your project. Find out from your contractor when these subcontractors started work and when these suppliers delivered goods or materials. Then wait 20 days, paying attention to the Preliminary Notices you receive. PAY WITH JOINT CHECKS. One way to protect yourself is to pay with a joint check. When your contractor tells you it is time to pay for the work of a subcontractor or supplier who has provided you with a Preliminary Notice, write a joint check payable to both the contractor and the subcontractor or material supplier. For other ways to prevent liens, visit CSLB's website at www.cslb.ca.gov or call CSLB at 1-800-321-CSLB (2752). Remember, if you do nothing, you risk having a lien placed on your home. This can mean that you may have to pay twice, or face the forced sale of your home to pay what you owe.

- 14. THREE-DAY RIGHT TO CANCEL. You, the Owner, have the right to cancel this contract within three business days. You may cancel by e-mailing, mailing, faxing, or delivering a written notice to the contractor, or sign and return the signed Three Day Right to Cancel Notice appended included in this agreement at the contractor's place of business by midnight of the third business day after you received a signed and dated copy of the contract that includes this notice. Include your name, your address, and the date you received the signed copy of the contract and this notice. If you cancel, the contractor must return to you anything you paid within 10 days of receiving the notice of cancellation. For your part, you must make available to the contractor at your residence, in substantially as good condition as you received it, any goods delivered to you under this contract or sale. Or, you may, if you wish, comply with the contractor's instructions on how to return the goods at the contractor's expense and risk. If you do make the goods available to the contractor and the contractor does not pick them up within 20 days of the date of your notice of cancellation, you may keep them without any further obligation. If you fail to make the goods available to the contractor, or if you agree to return the goods to the contractor and fail to do so, then you remain liable for performance of all obligations under the contract.
- 15. INFORMATION ABOUT THE CONTRACTORS STATE LICENSE BOARD (CSLB). CSLB is the state consumer protection agency that licenses and regulates construction contractors. Contact CSLB for information about the licensed contractor you are considering, including information about disclosable complaints, disciplinary actions and civil judgments that are reported to CSLB. Use only licensed contractors. If you file a complaint against a licensed contractor within the legal deadline (usually four years), CSLB has authority to investigate the complaint. If you use an unlicensed contractor, CSLB may not be able to help you resolve your complaint. Your only remedy may be in civil court, and you may be liable for damages arising out of any injuries to the unlicensed contractor or the unlicensed contractor's employees. Only projects in excess of \$1 million each qualify as similar for this Project. Listed projects shall have included at least three of the following items: low voltage systems, interior acoustical treatments, prefabricated furniture or shelving systems, custom millwork, relocation or construction of architectural and/or structural walls, new finishes (carpet, tile, paint) and/or utility stub outs/feeds.

Bidder qualifications called for to be submitted at time of bid include, but are not necessarily limited to:

- 1. The Contractor shall have held a California Contractors License for a minimum of five (5) continuous years prior to the bid opening date for this Project. The license used to satisfy this requirement shall be of same type required by the contract.
- 2. License classification shall be as required by the contract specifications.
- 3. The Contractor shall perform at least 50% of the contract price with its own forces.
- 16. <u>LISTING SUBCONTRACTORS</u>: Each bidder shall submit a list of the proposed subcontractors on this Project as required by the Subletting and Subcontracting Fair Practices Act (Government Code Section 4100 and following). Forms for this purpose are furnished with the contract documents. The name and location of business of any subcontractor who will perform work exceeding 1/2 of 1% of the prime contractor's total bid or ten thousand dollars (\$10,000.00), whichever is greater, <u>must</u> be submitted with the bid. Any other information regarding the foregoing subcontractors that is required by District to be submitted may be submitted with the bid, or may be submitted to District up to 24 hours after the deadline established herein for receipt of bids. The additional information must be submitted by the bidder to the same address and in the same form applicable to the initial submission of bid.
- 17. WORKER'S COMPENSATION: In accordance with the provisions of Section 3700 of the Labor Code, the Contractor shall secure the payment of compensation to his employees. The Contractor shall sign and file with the District the following certificate prior to performing the work under the contract: "I am aware of the provisions of Section 3700 of the Labor Code which require compensation or to undertake self insurance in accordance with the provisions of that code, and I will comply with such provisions before commencing the performance of the work of this contract." - 18. <u>BID DEPOSIT RETURN</u>: Deposits of three or more low bidders, the number being at the discretion of the District, will be held for ninety (90) days or until posting by the successful bidder of the Bonds required and return of executed copies of the contract, whichever first occurs, at which time the deposits will be returned after consideration of the bids.

Copies of all collective bargaining agreements relating to the work as set forth in the aforementioned Labor Code are on file with the Department of Industrial Relations, Division of Labor Statistics and Research.
- 24. <u>PERMITS, FEES AND LICENSES</u>: The Contractor shall possess a valid business license as required by the City of Placentia, prior to the issuance of the first payment made under this Contract.
- 25. <u>TIME OF COMPLETION AND LIQUIDATED DAMAGES</u>: Bidder must agree to commence work on or before the date of written "Notice to Proceed" of the District and to fully complete the Project within one hundred fifty-four (154) calendar days thereafter. Within 45 days of receipt of the Claim, or any extension thereof agreed upon by the District and the Contractor, the District will conduct a reasonable review of the Claim and provide the Contractor with a written statement identifying what portion of the Claim is disputed and what portion is undisputed. Payment of any undisputed portion of the Claim shall be made within 60 days after the District issues its written statement. If the District does not provide a written statement within the time specified, the Claim shall be deemed rejected.

If the Contractor disputes the District's written statement or if the Claim is deemed rejected, the Contractor may demand in writing by registered or certified mail to the District, return receipt requested, an informal conference to meet and confer in an effort to settle the disputed portion of any Claim. Within 30 days of receipt of such written demand, the District shall schedule a meet and confer conference.

If any portion of the Claim remains in dispute after the conference, the District shall, within 10 District business days of the conclusion of the conference, provide the Contractor with a written statement identifying any portion that remains in dispute and any portion that is undisputed. Payment of any undisputed portion shall be made within 60 days after the District issues its written statement. Any remaining disputed portion shall be submitted to nonbinding mediation in accordance with Section 9204(c)(2)(B), unless the Contractor and District waive the mediation upon mutual written agreement.
