



A former CEO of two companies, including California Biomedical which he successfully "took public", Freschi concluded his private sector experiences as an executive for six years in financial planning.

Today, Freschi serves as First Vice President of ISDOC. He also serves as a Director of the Serrano Water District. In January of 2009 Governor Arnold Schwarzenegger appointed Rich Freschi as a member of the Santa Ana Regional Water Quality Control Board. Freschi is also a member of the Water Advocacy Committee of Orange County.

John B. Withers has served on the Irvine Ranch Water District Board of Directors since 1989 and subsequently re-elected to serve on the Board in four elections. He served as President of the Board in 2004 and in a number of other officer capacities as well. Wither serves on the Engineering and Operations and Asset Management Committees as well as various Ad Hoc Committees.

Withers is a Partner with California Strategies, LLC in Irvine, a statewide, strategic government relations firm. In past positions, Withers served as Vice President of Community Development for Lewis Operating Corp. and as Director of Water Resources for Psomas & Associates, a civil engineering and planning firm based in Costa Mesa. He was also the Director of Governmental Affairs for the Orange County Region of the Building Industry Association of Southern California, and a legislative advocate for Crocker Bank and a major trade association in Sacramento at the state capital.

Since 1995, Withers has served as Commissioner to the Orange County Local Agency Formation Commission, an agency which addresses local government organization and efficiency matters. Withers is also on the Board of Directors of the Orange County Sanitation District and knowledgeable in current wastewater operational and policy issues.

Withers also served as Chairman of the Santa Ana Regional Water Quality Control Board, having been appointed by the Governor in 1992 where he developed extensive water quality expertise. Withers participates on the Board of the National Water Research Institute.

A native Southern Californian, Withers received his B.A. from UCLA in economics with a specialization in urban studies in 1979. He was selected as a CORO Foundation Fellow and received a master's degree in urban studies from Occidental College in 1988. Community activities include membership in the UCLA Alumni Association, youth sports and Mariners Church.

A resident of Irvine since 1984, Withers and his wife Katie live in Turtle Rock. They have three grown children, Carolyn, Gordon, and Peter.

With over 25 years of local government experience, I have a proven record of committed leadership to the County of Orange and a deep knowledge and understanding of critical issues that are facing local government. - <u>Budget Management:</u> Reduced the LAFCO budget apportionment for special districts and cities for two consecutive fiscal years (FY 08/09 and FY 09/10) for a 15% total cumulative reduction. Selected an independent auditor to review LAFCO's revenue and expenditures and provided more transparency of the LAFCO's operations to funding agencies and the public.
- <u>LAFCO Analysis and Studies/Island Annexations:</u> Completed the adoption of Spheres of Influence for 33 cities and 29 special districts, developed prototype fiscal models for three county islands; completed the Rossmoor incorporation and the voluntary consolidation of the Orange Park Acres Mutual Water Company with the Irvine Ranch Water District; completed the MWDOC Governance Study and issued a final report; and issued recommendations on Orange/Los Angeles potential boundary adjustments.

Over the last four years I have been an effective advocate for fairly and appropriately implementing the Municipal Service Review (MSR) process. Shawn Dewane, was appointed by the Board of Directors in 2005 and was then elected by the public in 2006. He is currently serving his second consecutive term as President and was First Vice President in 2008.

Mr. Dewane is a strong believer in the effectiveness of small local government, most specifically special districts. Special districts are more responsive to the public and very efficient due to their single focus.

During Mr. Dewane's tenure Board President he led the charge for refinancing debt saving customers nearly \$2 million.

CHARLEY WILSON Director Santa Margarita Water District

As a Director of the Santa Margarita Water District, Charley Wilson is an active and dynamic force in providing leadership to a customer base of more than 100,000 residents and businesses in Mission Viejo, Rancho Santa Margarita and the unincorporated areas of Coto de Caza, Las Flores, Ladera Ranch and Telaga. The Santa Margarita Water District is the second largest retail water agency in Orange County, which serves as the lifeline to the fastest growing area in Orange County and is responsible for supplying clean, affordable, reliable water and wastewater to a multi-million dollar economy.

Wilson most recently was elected as Chairman of the Southern California Water Committee, a nonprofit, nonpartisan, public education partnership between cities, counties, business, industry, agriculture and water agencies dedicated to securing adequate, reliable affordable, quality water for Southern California.

Wilson was also selected by the Special Districts of Orange County to serve as their alternate representative to the Local Area Formation Commission (LAFCO). LAFCO is a state mandated local agency responsible primarily for establishing jurisdictional boundaries and forming new cities or districts.

Charley has been a leading public affairs professional in Southern California for more than 25 years. Wilson has spent the past 18 years in the electric utility industry, with Southern California Edison, where he coordinates the development and implementation of strategic planning and communication efforts to align company interests with local, state and federal government officials and agencies.

Prior to joining Southern California Edison, he served as director of community and media affairs for State and U.S. Senator John Seymour. He has also worked in sports radio and television with ABC, ESPN, and the Netherlands Broadcast Company.

A frequent lecturer and university level instructor, Wilson was invited to provide advanced political campaign and communications seminars to train candidates and political parties in Novosibirsk, Russia, Wilson has also hosted and produced "Orange County Outlook," a locally produced television show highlighting current events, political debate and economic development activities in Orange County.

A graduate of UCLA, Charley earned his BA degree in political science with an emphasis in international relations and public administration. He has done some work toward an MA in organizational leadership at Chapman University.

INDEPENDENT SPECIAL DISTRICT SELECTION COMMITTEE

RULES OF PROCEDURE adopted February 10, 1994

A. <u>Registration</u>

Each member of the Selection Committee shall be entitled to one vote for each independent special district of which he or she is the presiding officer (or alternate board member selected by the district's board). Each member shall provide written authorization (such as resolution or minute excerpt) at the time of registration.

Each voting member shall register and sign a declaration of qualification. The member will then be given ballots and other voting materials.

B. Quorum

Members representing a majority of the eligible districts shall constitute a quorum. Before calling the meeting to order, the chair shall verify that a quorum has registered and is present.

C. <u>Nomination</u>

Independent special districts may submit nominations for the regular member positions and the alternate position. Such Nominations shall be submitted on forms to be prepared by the Executive Officer and may be accompanied by resumes [and other written material] if desired. ALL NOMINATION FORMS MUST BE RECEIVED BY THE EXECUTIVE OFFICER ON OR BEFORE 5:00 P.M. ON THE 10TH DAY PRIOR TO THE DATE OF THE ELECTION MEETING. The Executive Officer will distribute a copy of the nominations and accompanying materials to each member at least five (5) days prior to the date of the election meeting.

D. Voting

Voting shall be conducted separately for each position. A candidate must receive a majority of the votes cast in order to be elected. In the event no candidate receives a

majority, run-off balloting shall be conducted between the two candidates receiving the highest number of votes. In the case of a tie in the second highest total, the tied candidates will all be included in the runoff. Balloting will continue until one candidate receives at least a majority of the votes cast.

The above process shall be conducted to elect the first regular member from among all regular member nominees.

To elect the second regular member, the above process will then be repeated among all remaining nominees for the regular member positions.

The above process will then be followed to elect the alternate member from the alternate member nominees.

E. <u>Selection of Terms</u>

The candidates elected for the two regular member positions shall draw lots for the four-year term and the two-year term.
