BACKGROUND

On November 13, 2018 the Library began a formal competitive bidding process for the renovation project. Three companies participated in the onsite walkthrough with library staff. On December 12, 2018, the Library completed the bidding process. One bid from Cal-City Construction was received, in the amount of \$1,469,100. At the December 18, 2018 Unusual Date Board meeting, the Board approved library staff to pursue a discussion of the budget with eMar Studio and Cal-City Construction for a total project not to exceed \$2.5 million in total. At the January 23, 2019 Unusual Date Board meeting, a decision was made to reject all bids and re-advertise the Request for Proposals (RFP) as the cost reductions proposed by Yamada Enterprise and Cal-City Construction would eliminate key service model component of the project.

The RFP was re-posted on the District's website, front entrance display case, and on Dodge Data & Analytics (construction and bidding website). Additionally, library staff received recommendations from other libraries and local chamber of commerce and followed through with an invitation to submit bids.

On February 28, 2019, the District received three proposals.

Attachment A is the Bid Tabulation.

Attachment B is the proposal from Alonco Construction, Inc. (\$1,099,898)

Attachment C is the proposal from Cal-City Construction, Inc. (\$1,198,880)

Attachment D is the proposal from Vincor Construction, Inc. (\$1,194,213.73)

State law requires the Library District to award the contract to the lowest responsible bidder; provided the bidder's bid is responsive to the request for bids. The Board of Trustees may waive minor variations in a bidder's bid, as long as such variations do not give the low bidder a competitive bidding advantage. In this case, the lowest bidder submitted a performance bond for only 36% of the bid price. The request for bids requires a performance bond at 100% of the bid price. Given that a 36% performance bond would be less expensive that one for 100%, the lowest bidder gained a competitive bidding advantage over the other bidders. In addition, it is routine for public agencies to require a performance bond at 100% of the

contract price to protect the public agency in the event the contractor awarded the bid does not perform. A 50% performance bond would not provide the Library District with that level of protection. Finally, the inability of a contractor to get a 100% bid bond can be, in some cases, evidence of the financial capability of the contractor. For the above reasons, staff's recommendation is that the Board of Trustees find that the lowest bid submitted by Alonco Construction, Inc. be found non-responsive and that the contract for the Library remodel be awarded to the second lowest bidder, Vincor Construction, Inc.

At the February 28, 2019 Board of Trustees meeting, it was authorized that the special meeting be continued to March 5, 2019. All bidders were notified on March 1, 2019 of the Board's decision and the upcoming March 5, 2019 meeting.

Fiscal Impact: \$1,194,213.73

March 5, 2019

The Library District has received a protest from Cal-City against the bid submitted by Vincor, the apparent lowest responsible bidder. The thrust of the Cal-City's protest is that Vincor failed to acknowledge that it received the two addendums modifying the contract documents and specifications to be bid upon. Cal-City notes that the addendum themselves state they are material to the bid and that failure to indicate receipt of the addendum is grounds for rejection. Cal-City further contends that without the acknowledgment, the Library cannot be confident that the bid price submitted by Vincor includes the work provide for in the two addendums.

The Library District staff, along with Legal Counsel David DeBerry, reviewed the Cal-City protest. The conclusion was that while Vincor did fail to acknowledge receipt of the two addendums on the Bid Form, the Library District did receive verification from Vincor prior to bid opening that it received the addendums. Per the attached declaration of Alyssa Stolze (Attachment A), the administrative assistant to the Library Director, Ms. Stolze states that she called all three bidders on February 6th, 2019, and February 26, 2019, for the purpose of ascertaining whether they had received Addendum 1 and Addendum 2, which were issued and e-mailed to the bidders, on those dates. Ms. Stolze states in her declaration, that all three bidders acknowledged receipt of both addendums. The purpose of the addendum acknowledgment was to ensure the addendums were received so that the bidders would consider them in submitting the bids. That purpose was served and fulfilled by Ms. Stolze e-mailing the addendums to each bidder and confirming receipt by way of a phone call.

Second, each addendum provides, "Please indicate your receipt of this Addendum in the space on the Bid Form." However, neither the bid form submitted by Cal-City or Vincor have a page where there is a space to acknowledge receipt of the addendums. It does not appear that such a form was provided in the bid documents. This, coupled with the fact that Vincor confirmed over the phone that it had received the addendums, is likely the reason a written acknowledgment was not received from Vincor. Also attached is Vincor's declaration (Attachment B) that it received and considered the bid addendums. However, given that this came after bids were opened, is not of significant evidentiary value in the Board's decision.

The Board may waive minor bid irregularities if it does not result in a competitive bidding advantage to any bidder. Given that Ms. Stolze independently verified with Vincor that it received the two addendums prior to bid opening, the failure to acknowledge receipt thereof on a non-existent bid form, does not result in any competitive bidding advantage to Vincor. The Board may waive this irregularity and award the contract to Vincor.

Cal-City submitted another reason for protesting the award to Vincor late Monday. The basis for this protest was that Cal-City exchanged e-mails with the Library District's Project Manager Erik

Mar, seeking clarification of the bid documents. However, Cal-City states these clarifications did not get incorporated into the addendums and as a result, Cal-City's bid was based on different information than Vincor's.

However, Cal-City's rationale only calls into question the validity of Cal-City's bid, it does not taint Vincor's bid. The bid package provided to the bidders provides in Section 9 in relevant part: "Any interpretation or correction of the Contract Documents and Specifications will be made only by addendum duly issued and a copy of such addendum will be mailed or delivered to each person receiving a set of the contract document. No person is authorize to make any oral interpretation of any provision in the Contract Documents and Specifications to any bidder, and no bidder is authorized to rely on any such unauthorized oral interpretation." In short, if it is not in the Contract Documents and Specifications or an addendum, it is not part of the work to be bid and a bidder cannot rely on it. If anything, Cal-City's second rationale for its bid protest calls into question the validity of Cal-City's bid, not Vincor's, since there is no evidence suggesting that Vincor relied on information other the Contract Documents and Specification or the addendums. To the extent any bidder relied on information provided in an e-mail, it did so at its own risk.

Alonco Construction is a general contractor that is perfectly capable of performing the work required to complete the project at the Placentia Library at prevailing wage. Unfortunately, Alonco Construction is not able to obtain a bond equal to the amount of the contract. The max bonding achievable by Alonco Construction is \$400,000.00. Therefore, there is no bid bond or performance bond accompanying this attached bid. Alonco Construction is submitting without bonding and this explanation per my conversation with Jeanette Contreras.

This job could easily be done by setting up a proper payment schedule assuring payments are made as the work is completed and accepted by the library or city inspectors. The last two large projects Alonco Construction performed were done in this manner and without performance bonding. Also the cost of the bond would cost the library an additional \$30,000.00 for a bond covering the full amount of the project.

The only way Alonco Construction would be able to do this work with bonding would be to possibly split it up in three contracts in order for Alonco Construction to bond up.

ADDITIONAL TERMS AND CONDITIONS

- 1. Terms and Conditions. These are the printed terms of the contract and are included as part of your agreement with Contractor. The terms are legally binding, please read carefully.
- 2. <u>LIABILITY LIMITATION</u>. Contractor makes the following express, limited warranty: Contractor will perform its work in a good and workmanlike manner; it will use the degree of care and skill ordinarily exercised under similar circumstances by members of its profession. This warranty is in lieu of all other warranties or representations either express or implied. Should Contractor be found negligent in the performance of its work or to have made and breached any express or implied warranty, representation or contract, Owner agrees that the maximum aggregate amount of liability of Contractor shall be limited to \$25,000.00 or the total amount paid to Contract, whichever is greater.
- 3. Code Violations. Contractor is not responsible for existing violations of local building codes and/or ordinances.
- 4. Personal Guarantee: Whether the undersigned signs on behalf of an individual, sole proprietor, corporation, partnership, or other entity, the undersigned irrevocable and unconditionally personally guarantees payment for the Subject Work.
- 5. Assignment. Contractor has the right to assign or delegate rights and/or duties under this Contract, including without limitation any right to compensation under this Contract. Owner may delegate or assign duties under the Contract but shall remain personally liable for compensation to Contractor.
- 6. Attorneys' Fees. The prevailing party in any demand, action, judicial proceeding, motion or arbitration shall be entitled to recover from the unsuccessful party all costs, expenses, actual attorneys' fees and expert witness fees relating to and/or arising out of such demand or proceeding and/or arising out of any post-judgment proceeding. Any award or judgment shall contain a specific provision for the recovery of all subsequent costs, expenses, actual attorneys' fees and expert witness fees incurred in connection with any post-judgment collection action. Owner acknowledges that Contractor's damages shall include lost profits, overhead, incidental and consequential damages.
- 7. Hold Harmless Agreement. Contractor is not responsible for damage resulting from flood or fire, including but not limited to water, sewage, or smoke. Contractor shall not be liable for existing conditions, including, but not limited to water damage, smoke damage, fungi, mold, mildew, poor indoor air quality, sick building syndrome, asbestos, biological or chemical hazards, latent defects, prior flooding and structural problems. Contractor in no way will be held liable for natural consequences of flooding, fire, mechanical malfunction or interferences of work by any other entity or party involved. Contractor is not responsible or liable for any persons or animals that remain at the premises or in the structure during work. Owner agrees to indemnify and hold Contractor harmless and agrees, at its own expense, to defend any suit or action brought against Contractor founded on or arising out of such damages, conditions or claims.
- 8. Stop Work. Should Owner fail to issue payment within 5 days of a demand, notice or invoice from Contractor, in addition to all other remedies available, may stop work and/or terminate the contract and enter the premises and remove any portion of or all materials or goods installed or affixed to the Property as part of the Subject Work so long as the removal does not substantially interfere with materials or goods not part of the Subject Work.
- 9. Schedule of Progress Payments. Owner will provide progress payment for the value of each scope of work within 5 days after notice that the respective scope of work is completed. The Progress Payment

will be for the amount as outlined in the respective schedule of progress payments, which describes the phase of work and the amount owed.

- 10. Note About Extra Work And Change Orders. Extra Work and Change Orders become part of the contract once the order is prepared in writing and signed by the parties. The order must describe the scope of the extra work or change, the cost to be added or subtracted from the contract, and the effect the order will have on the schedule of progress payments. Contractor's failure to comply with the requirements of this paragraph does not preclude the recovery of compensation for work performed based upon legal or equitable remedies designed to prevent unjust enrichment. Further, Owner acknowledges and agrees that in performance of the Project changes may be made at any given day and, for efficiency and time sensitivity, may be performed before a change order is written and executed. Owner specifically agrees to execute, within 24 hours, any change order presented by Contractor. If Owner disputes the change order, or any portion thereof, they must immediately, but in no event more than 24 hours after receipt, inform the Contractor in writing of the dispute and Contractor shall have the right to immediately cease work until such change order is resolved or stop work under section 8 above. Any time period wherein Contractor stops work, consistent with the terms of this agreement, will automatically extend the completion deadline for the same amount of days that work is stopped plus an additional 2 days in order for Contractor to recommence scheduling of the work.
- 11. Commercial General Liability Insurance (CGL). Contractor carries commercial general liability insurance as of the date of this contract.
- 12. Workers' Compensation Insurance. Contractor carries workers' compensation insurance for all its employees.
- 13. Mechanics Lien Warning. Anyone who helps improve your property but who is not paid may record what is called a mechanics' lien on your property. A mechanics' lien is a claim, like a mortgage or home equity loan, made against your property and recorded with the county recorder. Even if you pay your contractor in full, unpaid subcontractors, suppliers, and laborers who helped to improve your property may record mechanics' liens and sue you in court to foreclose the lien. If a court finds the lien is valid, you could be forced to pay twice or have a court officer sell your home to pay the lien. Liens can also affect your credit. To preserve their right to record a lien, each subcontractor and material supplier must provide you with a document called a '20-day Preliminary Notice.' This notice is not a lien. The purpose of the notice is to let you know that the person who sends you the notice has the right to record a lien on your property if he or she is not paid. BE CAREFUL. The Preliminary Notice can be sent up to 20 days after the subcontractor starts work or the supplier provides material. This can be a big problem if you pay your contractor before you have received the Preliminary Notices. 
